Millennium Cyclone System Solution is a specially formulated flushing solution developed for use with the Patented Millennium Cyclone* (by Garlock). The convenient 1 gallon packaging with quick connect fittings makes it quick and easy to use.

BASIC USE

Millennium Cyclone System Solution is used to flush residual adhesive component from the Cyclone pump and hose in preparation for long-term equipment storage. The Cyclone adhesive pump cart should be flushed with Millennium Cyclone System Solution immediately after use whenever the anticipated idle time for the pump is greater than two weeks.

APPLICATION

- 1. Ensure that power to the Cyclone pump is off.
- 2. Remove Millennium PG-1 adhesive bags from Cyclone by disconnecting the quick connect fittings.
- 3. Install box labeled Millennium Cyclone System Solution Part 1 (color coded white) onto the Cyclone tray labeled Part 1 (white) and connect black fittings.
- 4. Install box labeled Millennium Cyclone System Solution Part 2 (color coded blue) onto the Cyclone tray labeled Part 2 (blue) and connect gray fittings.
- 5. Restore power to the Cyclone pump. Place an approved waste container under the gun and remove the mixing nozzle.
- Slowly open the gun valves and pump entire contents of Millennium Cyclone System Solution into the waste container.
 To ensure all adhesive component material is properly flushed out of the pump, hoses, and gun all solution in Part 1 and Part 2 boxes must be used.
